## **KEYNOTE SPEAKER:**



Po-Hsuan (Paul) Hsu 許博炫教授 Professor and Yushan Scholar Department of Quantitative Finance College of Technology Management, NTHU

Professor Hsu's research focuses on the interaction between innovation economics, financial markets, and sustainability. He is a prolific publisher in leading academic journals, including Journal of Finance, Journal of Financial Economics, Review of Financial Studies, Management Science, Journal of International Economics, Journal of Financial and Quantitative Analysis, Research Policy and Contemporary Accounting Research.





#### **SUBMISSION PROCESS:**

The meeting invites all researchers at FIRN member institutions to submit completed papers focusing on the topic area of corporate finance. To facilitate group interaction, the number of presenters in the meeting will be limited. All the papers are double blind-reviewed by established international scholars. Applicants must commit to attending the whole 2-day meeting, including the group dinner. Submission is not open to doctoral students, although they may request to attend the meeting.

## PAPER SUBMISSION CONDITIONS:

- Only 1 paper per presenting author may be submitted.
- Papers may not be already accepted for publication.
- Paper author(s) must allow a copy of the paper to be made available to other conference participants.
- Only completed papers should be submitted.

SUBMISSION DEADLINE: 30 June 2023. Authors of accepted papers will be notified by 31 July 2023.

**SUBMISSION FORMAT:** Please submit (1) a blind copy of the manuscript without author information, and (2) a nonblind copy of the manuscript with a title page containing all author information. Only PDF documents can be submitted.
